1. Sail numbers are required. Either hull number or USSA number is acceptable. Compliance to minimum Coast Guard requirements is mandatory by all yachts. The Waiver form must be signed by the owner (on the back of this form).
2. All racers must have a valid PHRF-LIS certificate on file with ECSA. Apply on line at www.ECSA.net. It is not necessary to include a certificate with this entry if current.
3. Entry fee for the combined Spring and Summer Series is **\$175.00**. There are no partial entries.
4. Entries must be received by noon Tuesday to be included in next day's race. *Please make checks payable to "M.R.M.S.A." and mail your completed application, check and the signed waiver on the back to: MRMSA, P.O. Box 117, West Mystic, CT 06388 Attn: WNRS*
5. The Mudhead website is your friend. Use it frequently. The final Scratch Sheet will be posted on the web after 12 noon on the Tuesday before each race.

The **Mystic River Mudhead Sailing Association** is in no way to be held responsible for accidents, damage or injury to property or to yachts, crew or guests arising from any cause during or related to any race or activities of the **M.R.M.S.A.** Series. Weather and sea conditions must be evaluated by each skipper and his crew and each participant is responsible for determining whether it is safe for him/her to participate. The responsibility of wearing a life jacket rests upon the skipper and his crew. If assistance is provided by the Committee vessels and personnel, it is at the risk of the participants.

I hereby agree to all of the Conditions of the Mudhead Wednesday Night Racing Series and shall inform each member of my crew of these Conditions. I hereby warrant that my yacht will be outfitted, equipped and handled in accordance with these Conditions; that she will have all of the required equipment aboard; that she is seaworthy in hull, rig and gear; that she will be completely manned.
